



# CARERS ALLOWANCE AND OLDER CARERS



This leaflet applies to carers aged **60** and over.

Carers Allowance is paid to people who care for someone who receives either Attendance Allowance or Disability Living Allowance Care Component (only at the middle or highest rate – the lower Care rate or the Mobility Component do not count).

As many people have discovered, you cannot get Carers Allowance and State Retirement Pension at the same time. BUT you may still be better off by claiming.

There are two sorts of older carers who may be better off:

## WHO SHOULD CLAIM?

**1.** If you are over 60 (for a woman) and 65 (for a man) you probably get a State Retirement Pension.

Carers Allowance 'overlaps' with State Retirement Pension. If your State Retirement Pension is below the current rate for Carers Allowance, your pension 'topped up'.

So – claim Carers Allowance

*Example:* **Jean** (63) gets a State Pension based on the number of years she worked, totalling £30.00 per week.

She cares for her disabled sister, and claims a Carers Allowance top-up to a new total of £52.10 per week – an extra £23.10 per week.

## HOW TO CLAIM

Call the DWP Benefit Enquiry Line on 0800 882200 and ask for the claim form DS700 (SP).

**2.** HOWEVER, even if your existing pension is more than the Carers Allowance, you should still consider claiming if you:

- ✓ get Pension Credit, **or**
- ✓ get Council Tax Benefit/Housing Benefit, **or**
- ✓ do not get the above **but** have low capital.  
There is no upper capital limit for Pension Credit. For Housing or Council Tax Benefit the capital limit is £16,000.

◆ This is because you will have an ‘underlying entitlement’ to Carers Allowance (this is where the only reason that you cannot actually receive Carers Allowance is because you already being paid another benefit – e.g. Retirement Pension)

But this will still be enough to entitle you to an extra amount on your Pension Credit or your Housing Benefit/Council Tax Benefit, called a Carer Premium or Carer Addition. Which means more money!

◆ So the Carer Premium/Addition might mean getting more of these benefits **or** becoming entitled for the first time.

*Examples:*

**Jamilla** (70) cares for her disabled son. Her weekly state pension is more than Carers Allowance but she is also entitled to Pension Credit. She claims Carers Allowance and is sent a letter saying she has “underlying entitlement” to it. She tells her local Pension Service. This means an increase of over £27.00 to her weekly Pension Credit.

**Graham** (69) tried to get Pension Credit last year, but was refused as his other pensions were slightly too much. He looks after his disabled wife, and so he now makes a claim for Carers Allowance. His pensions are more than the Carers Allowance but he still has “underlying entitlement” to it. This means he is now entitled to Pension Credit, which includes a “Carer Addition”. He gets extra weekly income and full Housing/Council Tax Benefit.

## **HOW TO CLAIM**

### **Step ONE**

Make a claim for Carers Allowance

- Ring the 0800 882200, or the Pension Service Office which pays your State Pension.
- Ask for the form DS700 (SP).
- Fill in the form and send it back in the freepost envelope they provide.

### **Step TWO**

They will send you a decision. If you have “underlying entitlement” the letter will say so.

### **Step THREE: either**

**1a.** If you are not already getting Pension Credit, make a claim by getting the claim form from your local Pension Service office. When you make the claim remember to show them your Carers Allowance decision letter,

**or**

**1b.** If you do get Pension Credit already, just tell the Pension Service about your Carers Allowance decision.

**or**

**2.** For those only getting Housing or Council Tax Benefit tell your local Council Benefit Sections about the Carers Allowance decision.

## **POINTS TO REMEMBER**

- ◆ If the person you are caring for gets a special element of Income Support / income-related Employment & Support Allowance (called the Severe Disability Premium) or Pension Credit (called the Severe Disability Addition), your claim may reduce their benefit, so **Check First**.
- ◆ If you have any doubts or queries, **seek advice** – see over.

## **OTHER BENEFITS?**

- ◆ Carers should check out the way to reduce your Council Tax called Carers Discounts. It is not mean-tested, so your income or capital won't affect it – contact your local Council Tax office for details.
